### Scottrade® Mobile Application

#### MOBILE APPLICATION AND SERVICES END-USER SOFTWARE LICENSE AGREEMENT AND TERMS OF USE

**Please read this end-user Software License Agreement and Terms of Use (the "License") carefully before clicking the "Accept" button or downloading, installing, accessing or using the Scottrade Mobile Application (the "Mobile App") accompanying this license. By clicking the "Accept" button or downloading, installing, accessing or using the Mobile App, You are entering into and agreeing to be bound by the Terms of this License and the Terms and Conditions of the Scottrade, INC. ("Scottrade") Privacy Statement located at <https://www.scottrade.com/documents/alt/privacystatement.pdf> and incorporated herein.**

**If You do not agree to the Terms of this License, do not click the "Accept" button. If You do not agree with this License, Scottrade is not willing to grant You any right to use or License in the Mobile App, and You may not download, install, access or use the Mobile App.**

**You acknowledge and agree that the Mobile App is provided as a supplement to Your Scottrade online Brokerage Account ("Your Account") and is not meant to be a replacement to Your Account or any service related to Your Account. All agreements and disclosures that You have entered into in connection with or that apply to Your Account, including, but not limited to, Your Scottrade Brokerage Account Agreement Terms and Conditions and Your Scottrade Bank Account Agreement (collectively, Your "Account Agreements"), also apply to the Mobile App and Your use thereof.**

**GENERAL.** The Scottrade Mobile App accompanying this License is licensed, not sold, to You for use strictly in accordance with the terms and conditions of this License. You agree to use the Mobile App in accordance with this License and any applicable usage rules of any third party mobile telephone, tablet or other device (each a "Mobile Device") or service provider or the third party from whom You are downloading this Mobile App (the "App Venues"). It is Your responsibility to review the terms and conditions of any App Venue and to determine what usage rules of such App Venue apply to You depending on (i) Your Mobile Device, (ii) the method by which You downloaded the Mobile App, and (iii) the App Venue from which You downloaded the Mobile App.

The term "Mobile App" shall refer to this Mobile App, including without limitation any software code, graphics, content, text, data, displays, documentation or other information, and any updates, enhancements, modifications or other changes to the Mobile App that may be made by Scottrade from time to time and in its sole discretion, and any service provided to You by Scottrade (the "Services") through the Mobile App.

The Mobile App is intended only for Your personal, non-commercial use and display. By using the Mobile App You represent and agree that You are a U.S. resident of legal age (18 years and over) and of legal competence to enter into this legally binding License. You represent and warrant that You are not (i) located in any country that is subject to a U.S. Government embargo or that has been designated by the U.S. Government as a "terrorist sponsoring" country; (ii) listed on any U.S. Government list of restricted or prohibited parties or a Specially Designated National or a Denied Person.

This Mobile App is intended to be made available only to U.S. residents. Because of the inherent nature of a Mobile Device, You agree that You shall comply with all local laws, rules and regulations of the country in which You reside or where You access the Mobile App. In addition, You agree to comply with all applicable laws, rules and regulations regarding the export of technical data from the U.S.

**SCOPE OF LICENSE AND RESTRICTIONS ON USE.** Scottrade grants You a personal, revocable, non-exclusive, non-transferrable limited license to install and use the Mobile App on Your Mobile Device to access and use the Services for Your personal, non-commercial use and display strictly in accordance with this License and Your Account Agreements and solely for the use and purpose as intended for the Mobile App.

You agree that You shall not (i) modify, decompile, disassemble, reverse engineer or attempt to derive the source code of the Mobile App; (ii) make any derivative works from or any modification, enhancement, copy or adaptation of the Mobile App; or (iii) create, design, engineer or use any "bot" or other technology in connection with the Mobile App.

You acknowledge and agree that from time to time and without notice to You, Scottrade may amend, modify, update or upgrade the Mobile App or create new versions of the Mobile App. You acknowledge and agree that Scottrade may automatically upgrade the version of the Mobile App that You are using on Your Mobile Device. You consent to such automatic upgrading on Your Mobile Device and agree that this License shall apply to any and all such upgrades.

You agree that, except as otherwise required by applicable law, rule or regulation, Scottrade may at any time in its sole discretion (i) terminate this License and Your use of the Mobile App; (ii) discontinue support of the Mobile App; (iii) expand, reduce or suspend any or all of the Services available on the Mobile App; or (iv) impose limits on certain transactions allowed on the Mobile App, including, but not limited to, the imposition of dollar amount limits of transactions on the Mobile App.

You acknowledge and agree that Scottrade may from time to time and without notice to You amend or modify this License and any terms and conditions of this License and Your use of the Mobile App and the Services. You acknowledge and agree that this License is available for Your review at any time on the Mobile App and that it is Your responsibility to review this License from time to time and confirm Your agreement to the License. If at any time You do not agree with the License, You agree that You shall immediately discontinue Your use of the Mobile App and remove the Mobile App from Your Mobile Device.

**INTELLECTUAL PROPERTY NOTICE.** The Mobile App is owned by Scottrade, Inc. or its affiliates, agents or licensors, as applicable. All rights, title and interest in and to the Mobile App are reserved by Scottrade and its affiliates, agents or licensors, as applicable. All trademarks (including logos, service marks, trade names and icons), copyrights, patents, trade secrets, content, publicity rights and other intellectual property (collectively, the "Intellectual Property") are proprietary to Scottrade, its affiliates, agents or licensors. You may not remove any proprietary notices, including, but not limited

to, copyright and trademark notices, from the Mobile App or alter, obscure or modify such notices in any way. Except as expressly and unambiguously provided herein, You do not possess, and Scottrade does not grant to You, any express or implied rights (whether by implication, estoppel or other legal theory) in or to the Mobile App or any other Intellectual Property.

You acknowledge and agree that You, and not Scottrade or any third party Mobile Device service provider or App Venue, shall be solely responsible for the investigation, defense, settlement and discharge of any intellectual property infringement claim or suit, any third party claims or any other harm or damages caused by, arising out of or resulting from Your use of or access to the Mobile App. You hereby release Scottrade and its employees, officers, directors, affiliates, agents and licensors from any and all liability caused by, arising out of or resulting from Your use of the Mobile App or the Services, including from product liability claims or any claim that the Mobile App fails to conform to any legal or regulatory requirement.

**YOUR USE OF THE MOBILE APP AND SERVICES.** You acknowledge and understand that certain Services available to You through the Mobile App, including, but not limited to, Your ability to conduct financial transactions, require data access or wireless internet capability. You agree that You are responsible for any such data access or wireless internet charges of Your Mobile Device service provider.

The Mobile App is designed to be accessible on multiple types of Mobile Devices and operating systems. Scottrade does not, however, make any representation or warrant that the Mobile App will be compatible with Your Mobile Device or any specific operating system version of Your Mobile Device or any other hardware, software, equipment or device installed on or used in connection with Your Mobile Device.

You agree that Your functional use of the Mobile App may be impacted by or dependent on Your wireless connection and speed or Your wireless service provider. You acknowledge and agree that it is possible that Your wireless connection can be interrupted or disconnected, or a feature of the Mobile App could be disabled, while You are conducting a financial transaction, including, but not limited to, when You are attempting to place a trade of a security.

You agree that it is Your responsibility to verify the status of any attempted transaction by reviewing Your Account, contacting Scottrade Customer Support at 1-800-619-7283 or online at [www.scottrade.com](http://www.scottrade.com) or visiting a Scottrade Branch Office.

You acknowledge and agree that Scottrade, and its affiliates, agents and licensors, shall have no liability to You for any losses, financial or otherwise, suffered by You arising out of or resulting from compatibility or inoperability problems or the failure of or Your failure to confirm any attempted transaction.

**PRIVACY AND SECURITY.** Use of the Mobile App involves the electronic transmission of data and information to and from Your Mobile Device across a wireless network provided by Your wireless service provider. You acknowledge and agree that Scottrade does not operate or control the wireless networks used to access Your Account, and that Scottrade is not responsible or liable for the privacy and security of Your wireless data and information transmissions. You agree that it is Your sole responsibility to confirm the privacy and security practices of Your wireless service provider and to only use a reputable wireless service provider.

You agree that Scottrade's Privacy Statement, which can be found at <https://www.scottrade.com/documents/alt/PrivacyStatement.pdf> shall apply to this License and Your use of the Mobile App.

You acknowledge and agree that it is Your responsibility to maintain the security of Your Mobile Device from unauthorized access. You further agree that in the event of any unauthorized access, or attempt to access, to Your Mobile Device or Your Account, You shall immediately notify Scottrade of any such access or attempt and cooperate with any investigation by Scottrade into such access or attempt.

**DISCLAIMER OF WARRANTIES; LIMITATIONS OF LIABILITY.** You expressly acknowledge and agree that Your use of the Mobile App is provided on an "as is" and "as available" basis and that Your use of the Mobile App and the services is at Your own risk. To the maximum extent permitted by law, Scottrade and its employees, officers, directors, affiliates, agents and licensors expressly disclaim all warranties with respect to the Mobile App and any services, content, data or other information available on or through the Mobile App, whether express or implied, including, but not limited to, the implied warranties of merchantability, fitness for a particular purpose, quiet enjoyment, title and non-infringement. Further, Scottrade makes no warranty that (i) the Mobile App or the services will meet Your requirements or expectations; (ii) the Mobile App will be uninterrupted, free from errors or defects or other harmful components; (iii) results of Your use of the Mobile App or the services will be accurate or reliable or without risk; (iv) any errors or defects in the Mobile App will be corrected; or (v) the content, data and/or other materials presented or displayed on or available through the Mobile App will be correct, accurate or reliable.

You agree that Scottrade and its employees, officers, directors, affiliates, agents and licensors shall not be responsible or liable for any damages caused by theft, unauthorized access (including, but not limited to, access to or alteration of Your account, transmissions or data due to Your conduct, inaction or negligence), failure of the Mobile App or Your mobile device, wireless connection failure or any other occurrences beyond the control of Scottrade or its affiliates, agents or licensors.

No information, instruction or advice, whether written or oral, obtained by You from Scottrade or an employee or agent of Scottrade shall create any warranty not expressly stated in this license.

Scottrade and its employees, officers, directors, affiliates, agents and licensors shall not be liable for any direct, indirect, incidental, consequential, special, punitive or exemplary damages or any other damages, which shall include, without limitation, damages for lost profits, business interruption, lost data, loss of business opportunity or other intangible or tangible losses (even if Scottrade or its affiliates, agents or licensors have been advised of the possibility of such damages), arising out of the use or inability to use the Mobile Application, whether or not such damages arise in contract, tort (including negligence) or otherwise. In any case, the entire liability of Scottrade and its employees, officers, directors, affiliates, agents and licensors, for any damages for whatever reason and under whatever theory of liability, shall be limited to five hundred dollars (\$500.00).

**SCOTTRADE BROKERAGE ACCOUNT TERMS.** You acknowledge, understand and agree that Your use of the Mobile App and Your access to Your Account through the Mobile App is governed by Your Account Agreements to which You have previously agreed, which include, but may not be limited to, Your Brokerage Account Agreement Terms and Conditions, in addition to this License. You

further acknowledge, understand and agree that there are certain terms, conditions and factors that may be unique to the Mobile App and the Services provided through the Mobile App, including, but not limited to: **(i) Trading**--Because of limitations on wireless connections, Your wireless service provider or Your Mobile Device, Your order/trade transmissions may not be received by Scottrade as quickly as if placed through other Scottrade trading platforms. If You choose to trade in volatile securities through the Mobile App and Your Mobile Device, You should consider placing limit orders instead of market orders; and **(ii) Order Change or Cancellation Requests**--You acknowledge, understand and agree that once an order is placed through use of the Mobile App, whether a market order or limit order, it may not be possible to cancel or change such order. You agree to exercise caution in placing any order and acknowledge and agree that any attempt You make to cancel an order is merely a request to cancel, and Scottrade makes no representation, warranty or guarantee regarding Your ability to cancel or change an order. You further acknowledge, understand and agree that Your attempt to cancel or change an order, particularly in connection with a market order, through the Mobile App can result in the entry and execution of duplicate orders, which shall be Your responsibility, without liability of Scottrade.

**APPLICABLE LAW AND VENUE.** This License is governed by the laws of the State of Missouri, United States of America, without regard to the conflicts of laws rules thereof or the United Nations Convention on Contracts for the International Sale of Goods. Scottrade does not claim that the Mobile App, the Services or any content or other information provided through the Mobile App are appropriate for use in locations other than the United States. If You choose to access or use this Mobile App in other locations, You do so on Your own initiative, and You are responsible for compliance with any applicable local laws, rules and regulations, as set forth above. If You take legal action relating to this License, You agree to file such action only in the Twenty-First Judicial Circuit of the State of Missouri (also known as the Circuit Court of St. Louis County) or the United States District Court for the Eastern District of Missouri, and You consent and submit to the exclusive personal jurisdiction of those courts for the purposes of litigating any such action. You further agree that any controversy, dispute, claim or grievance in connection with Your Account shall be subject to the arbitration provisions set forth in Your Account Agreements.

**MISCELLANEOUS.** This License shall not be amended, modified or altered, and no exception to this License shall be given, except by a writing signed by the General Counsel of Scottrade. In the event that any term of this License is found to be invalid or unenforceable by a court of competent jurisdiction and pursuant to a valid judicial decree, the remainder of this License shall remain valid and enforceable in accordance with its terms. Any failure by Scottrade to enforce any provision of this License shall not constitute a waiver of such provision or any other provision of this License or any subsequent breach of such provision or this License. The disclaimers of warranties and limitations of liability shall survive any termination of this License.
