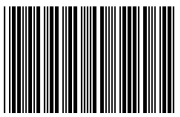

A \$25 fee applies to domestic wire transfers and a \$40 fee applies to international wire transfers. Be advised that intermediary and/or receiving institutions may charge additional fees. For international wires, currency exchange rate risk may apply if the intermediary or receiving institution converts the currency to a different denomination. Scottrade reserves the right to request additional verification prior to processing a wire transfer request. International wire transfers are available only through Scottrade, Inc., a registered broker/dealer, and are not available through accounts maintained at Scottrade Bank. Scottrade, Inc., reserves the additional right to reject requests for wire transfers at its sole discretion. Each of the undersigned requests that Scottrade execute the wire transaction described above, and acknowledges that: (i) any intermediary or receiving institution may charge additional fees; (ii) failure and delays in executing this request may occur for any variety of reasons, including inaccurate or ambiguous instructions, lack of available funds in the distributing account, an inability of Scottrade to verify the authenticity of the request or identity of the account holder or wire recipient, application of wire cut-off times, systems outages, or intermediary institution delays; (iii) the terms and conditions of the Scottrade account agreement apply; (iv) in the event this request is submitted by a custodian for a UTMA or other custodial account, the proceeds will be directed to meet the best interests of the minor account owner; (v) Scottrade reserves the right to not execute this request in its discretion; and (vi) I will not hold Scottrade liable, and agree to indemnify it, for any losses or damages that may arise in connection with this request. Be advised that in accordance with industry regulations, Scottrade may need to contact you to confirm the details and fees related to any international wires.
